 - It has been an encouraging year—Fr Hannam has been Vicar of St Bartholomew's for over ten years, having arrived in August 2013
 - In this time there has been tremendous growth in terms of parish size and offerings
 - Covid has had a notable impact on the parish—we've lost 27-28 members during this period, but have almost recovered to pre-pandemic levels
 - Thanks to its long term parishioners and many new-comers, the parish is in a place of strength and stability

8. The Diocesan Parish Administrator's Report – Kevin Forrest

- It has been encouraging to see the commitment and growth in giving and human resources in the parish over the last year
- In face of challenges to all faith communities, St Bart's has continued to grow and adapt
- The parish has continued to demonstrate tremendous strength and resilience and has a strong sense of its mandate to expand the community
- While the parish continues under diocesan administration—it is unlike other parishes in this scenario: St Bart's continues to demonstrate its strengths and the parish continues to grow
- Structural issues with the church are ongoing—and this has necessitated structural shoring to be put in place in the church basement and a series of next steps, including the temporary displacement of the St Bart's Children Centre (SBCC)
 - Money is in hand to undertake the next steps and the testing required to determine the next steps to ensure the long term functionality of our space
 - The future work will impact the use of the parish hall for an unknown period and we are hoping to get a better idea of the timeline and ways to mitigate the impact. This work is vital to ensure the long term work of the parish
 - o The SBCC will be relocating in the short-term to accommodate this work
 - The children's centre has been notified and there is space available for them at 420 Regent St.
 - o The possibility for the SBCC to return is front of mind for the parish
 - Sandy expressed that the SBCC would like the executive to put into writing that the SBCC will be welcomed back into the church hall, following the necessary building works
 - Kevin reported that the parish would be glad to continue all discussions with the SBCC and to look at opportunities for the SBCC to return to the parish hall
 - Next steps will be undertaken in the coming months
 - Questions were raised regarding the possibility of needing to relocate the parish in a more substantial way—this is not anticipated and the parish has not been given any indication of concerns re reinforcing the structure—work will be building on previous temporary shoring work
 - Disruptions to the worship schedule are not anticipated, but there will likely be some disruptions to food ministries and hospitality in the basement when the work is undertaken
